WARNING

Personal Protective Equipment: Wear protective eyewear (face shield or goggles), long-sleeved shirt, long pants, shoes, socks, and chemical-resistant gloves made of any waterproof material.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not add directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters or rinsate.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. Wash hands with soap and water promptly after use.

SHAKE WELL BEFORE EACH USE

DOGS AND CATS: To kill fleas, ticks and lice, thoroughly mix 1/2 oz (1 tablespoon) of this product with 1 gallon of warm water. For outdoor animals in areas of severe infestations, 2 oz (4 tablespoons) per gallon may be used. Make fresh solution daily. If animal's coat is very dirty, bathe first with Adams Shampoo. Dip should be applied to dry or damp (not wet) coat. Sponge or dip animal with diluted product making sure all areas are soaked to the skin. Let drip dry on animal. Do not rinse off! Repeat treatment every 7 days if necessary.

FIRST AID

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

NOTE TO PHYSICIAN

Probable mucosal damage may contradict the use of gastric lavage. Contains petroleum distillate.

STORAGE: Store in a cool, dry area away from heat or open flame. Do not contaminate water, food or feed by storage or disposal. Do not transfer contents to other containers.
