CATTLE/SWINE: 5 mL per 100 lb body weight twice daily.

HORSES:

FOALS: Not recommended for foals.

YEARLINGS: 5 mL per 100 lb body weight twice daily.

TWO YEAR OLDS: 15 mL twice daily.

STORAGE AND SAFETY:

This product is intended for intermittent or supplemental feeding only.

Store at room temperature 15°-30°C (59°-86°F).
