Over 100 lb - 5 chews daily

**Maintenance Administration**

5 to 15 lb - 1/2 chew every other day

16 to 30 lb - 1/2 chew daily

31 to 60 lb - 1 chew daily

61 to 100 lb - 2 chews daily

Over 100 lb - 2 1/2 chews daily
